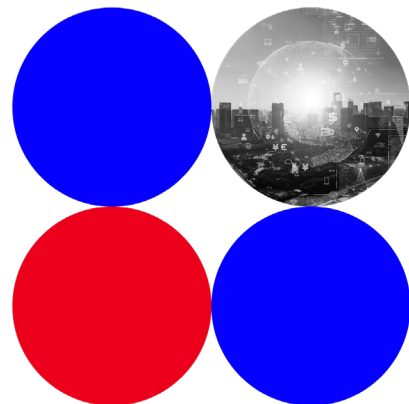

Metric	Description
Named User	<ul style="list-style-type: none">Number of individuals who are authorized to access the Recorded Future Platform for purchased capabilities.
Workforce Tier	<ul style="list-style-type: none">The number of unique workforce credentials associated with the customer's organization and its affiliates.
Scanned Assets	<ul style="list-style-type: none">The number of an organization's unique hostname or IP addresses included in an Attack Surface Intelligence project and scanned within the Attack Surface Intelligence capability.
External Identities	<ul style="list-style-type: none">The number of external credentials monitored by the customer's organization and its affiliates.External Identities refer to credentials not issued under Customer-owned domains but associated with an external-facing product or offering which is accessed by users outside the organization

Licensing Terms

Measurement

- All metrics are measured based on maximum usage unless otherwise specified.
- All metrics are licensed by "Tier" by default, which refers to a pre-determined usage band that establishes the pricing and maximum quantity of a given licensing metric.

Affiliates

- "Affiliate" means any entity that directly or indirectly controls, is controlled by, or is under common control with Customer.
- Includes entities whose assets, domains, or credentials are monitored within the Platform

Overuse

- Customers may not exceed licensed quantities. Additional usage may require purchase of additional capacity.
- API utilization is measured on a rolling 30-day average basis. For example, with a quota of 10,000 API Calls/day, the average number of Calls on a rolling 30-day basis cannot exceed 10,000. Rate limits may be enforced within certain APIs according to technical documentation provided.

Additional Limitations & Terms:

- Brand Intelligence capability is limited to (each from customer's organization) a maximum of 250 Customer executives, 5 Customer logos for machine-learning curation and 5 Customer organizations for impersonation monitoring.
- The Third-Party Intelligence capability Includes unlimited organization entity lookups via user interface.
- When licensing by Workforce Tier, the maximum number of monitored internal credentials within the Workforce identity Intelligence capability will equal the Workforce Tier.
- When licensing by Workforce Tier, there are no limits on the number of users who can access the Recorded Future Platform for purchased capabilities.
- When multiple packages or products are purchased, the highest applicable daily API Call limit among the purchased offerings shall apply.
- All packages also include Intelligence platform capabilities covering the Intelligence Graph, Recorded Future AI, access to all compatible integrations, APIs and collective insights.
